TERMS AND CONDITIONS

Invitation for Expression of Interest for Supply of Steel Almirah at Bengaluru International Airport, Devanahalli, Bangalore.

1. INTRODUCTION

Bangalore International Airport Limited (“**BIAL**”), the owner and operator of the Bengaluru International Airport (“**Airport**”), is a public limited company, registered under the Companies Act, 1956. BIAL is committed to establishing this Airport as one of India’s leading airports, in terms of quality and efficiency and set a benchmark for the future commercial development of Indian airports.

2. BROAD SCOPE OF WORKS

BIAL intends to purchase Steel Almirah (**‘Almirah’**) as per quality specification and Bill of Quantity stipulated in **Annexure-1**. In order to purchase Almirah, BIAL invites Expression of Interest (“**EOI**”) from resourceful, experienced and reputed suppliers for the Supply of Almirah. Interested parties, with the experience stipulated in this document and desiring to qualify to participate in the tender are invited to apply expressing their interest on terms and conditions as stipulated hereunder.

3. ELIGIBILITY CRITERION

Prequalification is open to suitably qualified and experienced suppliers who can submit their expression of interest. Applicants shall be eligible to participate in the tender, if they fulfill all the following requirements:

- 3.1 Experience of supplying large quantity and timely delivery of branded Almirah in the last 3 years;
- 3.2 Experience of supplying large quantity of Almirah in the last 3 years for the value as mentioned below:
 - (i) One order for a value of not less than Rs.22 Lakhs; or
 - (ii) Two orders for a value of not less than Rs. 15 lakhs.

4. EXPRESSION OF INTEREST

EOI must be submitted with the above particulars, supported by documentary evidence and shall include the following:

- 4.1 Detailed company/firm profile and capability;
- 4.2 General Information as per attached **Form I: General Information**;
- 4.3 Annual reports for the last two years;
- 4.4 Organization structure and details of make/model/type/size with other specifications of Almirah;
- 4.5 Copy of Income tax, Pan Card & service tax registration;
- 4.6 Copy of approval from statutory/regulatory authorities, wherever applicable; and
- 4.7 List of most important customers/owners indicating the contact particulars of the concerned person.

Based on the details furnished in the EOI application, BIAL will issue the Request for Proposal (RFP) document(s) to shortlisted applicants.

5. OTHER CONDITIONS

- 5.1 BIAL reserves the right to accept or reject any or all EOI without assigning any reasons and is not obliged to correspond with the applicants in this regard. Further, BIAL reserves the right to change and / or cancel the pre-qualification and tender process and / or review / revise the pre-qualification criteria at any time without prior notice or without assigning any reasons whatsoever, and this shall be without prejudice to its right to re-tender at any time in the future and in such case, no applicant/intending applicant shall have any claim arising out of such action.
- 5.2 BIAL reserves the right to issue amendments to the EOI and / or these Terms and Conditions by issue of an addendum, at any stage, without liability or any obligation for such invitation and without assigning any reason. This request for EOI does not give rise to any rights in rem and is not an offer or an invitation to offer.
- 5.3 Participation by any party in this EOI pursuant to the invitation by BIAL, shall be considered to be an acceptance of all the terms and conditions of this invitation by such party and no claims or disputes raised by it during or subsequent to the award process shall be entertained by BIAL.

- 5.4 All documents and other information supplied by BIAL or submitted by an applicant to BIAL, shall remain or become the property of BIAL. BIAL will not be liable to return any application or any information provided along therewith.
- 5.5 The applicants shall bear all costs associated with the preparation and submission of its EOI. BIAL shall in no case be responsible or liable for these costs, regardless of the conduct or outcome of EOI process.
