INVITATION FOR EXPRESSION OF INTEREST

Invitation for Expression of Interest for empanelment of vendors for purchase of scrap items at Bengaluru International Airport, Devanahalli, Bangalore.

1. INTRODUCTION

Bangalore International Airport Limited (“**BIAL**”), the owner and operator of the Bengaluru International Airport (“**Airport**”), is a public limited company, registered under the Companies Act, 1956. BIAL is committed to establishing this Airport as one of India’s leading airports, in terms of quality and efficiency and set a benchmark for the future commercial development of Indian airports.

2. BROAD SCOPE OF WORKS

BIAL intends to dispose of the scrap items to be generated during the expansion of the terminal at the Airport. In connection with the same, BIAL invites Expression of Interest (“**EOI**”) for empanelment from resourceful, experienced and reputed vendors for the purchase of the scrap items. Scrap materials will be made available as and when generated or periodically on ex-works basis to the empaneled vendors. Interested vendors, with the experience stipulated in this document and desiring to qualify for the empanelment stipulated above, are invited to apply expressing their interest on terms and conditions as stipulated hereunder.

3. PERIOD OF EMPANELMENT

Empanelment would be *for a period of two years* subject to satisfactory service. If the service provided by the vendor is found to be unsatisfactory or if at any time it is found that the information provided for empanelment or for any tender is false or if irregularities shown by the vendor for applying for the tenders, BIAL reserves the right to remove such vendors from the empanelled list without giving any notice to the vendor in advance.

4. ELIGIBILITY CRITERION

Prequalification is open to suitably qualified and experienced vendors/applicants.

5. EXPRESSION OF INTEREST

EOI must be submitted with the above particulars, supported by documentary evidence and shall include the following:

- 5.1 Detailed company profile and capability;
- 5.2 General Information as per attached **Form I: General Information** annexed as **Annexure I**;
- 5.3 Proof of financial capability of the vendor for performance of the scope of works;
- 5.4 Organization structure, tools and plants, technical capacity, details of skilled man power to be engaged for the execution of the work stipulated under this EOI;
- 5.5 Copy of Income tax PAN Card;
- 5.5 Copies of relevant approvals from statutory/regulatory authorities, wherever applicable; and
- 5.7 List of most important customers/owners indicating the contact particulars of the concerned person along with details of scraps handled during the past 5 years.

Based on the details furnished in the EOI application, BIAL will qualify vendors for empanelment.

6. OTHER CONDITIONS

- 6.1 The vendor, if earlier empanelled with BIAL for the same scope of works, should have satisfactory record in performance of the same. BIAL shall have the right to reject the proposal of such vendors where past performance with BIAL is not satisfactory. Any vendor, who is already suspended/blacklisted by BIAL for non-performance is not eligible to participate.
- 6.2 Any vendor, who after being empanelled under this empanelment, fails to participate in more than three (3) tenders floated by BIAL, would be blacklisted.

- 6.3 While deciding upon the selection of vendors, emphasis will be given on the ability and competence of applicants to do quality work within the specified time schedule. The decision of BIAL in selection of the vendors for empanelment will be final.
- 6.4 If called for, the vendor should be ready to participate in BIAL's tender process as per the terms and conditions of the respective RFP.
- 6.5. The specific terms and conditions for the scope of works may differ depending upon the nature of the scrap materials.
- 6.6 BIAL reserves the right to accept or reject any or all EOI without assigning any reasons and is not obliged to correspond with the applicants in this regard. Further, BIAL reserves the right to change and / or cancel the pre-qualification and / or review / revise the pre-qualification criteria at any time without prior notice or without assigning any reasons whatsoever, and this shall be without prejudice to its right to re-tender at any time in the future and in such case, no applicant/intending applicant shall have any claim arising out of such action.
- 6.7 BIAL further reserves the right to issue Request for Proposal (RFP) to vendors it deems eligible and qualified based on the evaluation of the responses received. Acceptance of the EOI for empanelment by BIAL would not guarantee the award of contract to the empaneled vendor.
- 6.8 BIAL reserves the right to issue amendments to the EOI by issue of an addendum, at any stage, without liability or any obligation for such invitation and without assigning any reason. This request for EOI does not give rise to any rights in rem and is not an offer or an invitation to offer.
- 6.9 Participation by any party in this EOI pursuant to the invitation by BIAL, shall be considered to be an acceptance of all the terms and conditions of this invitation by such party and no claims or disputes raised by it during or subsequent to the award process shall be entertained by BIAL.
- 6.10 All documents and other information supplied by BIAL or submitted by an applicant to BIAL, shall remain or become the property of BIAL. BIAL will not be liable to return any application or any information provided along therewith.
- 6.11 The applicants shall be bear all costs associated with the preparation and submission of its EOI. BIAL shall in no case be responsible or liable for these costs, regardless of the conduct or outcome of EOI process.

6.12 This invitation is only for the purpose of empanelment and not a Request for proposal (RFP) and no commercials need to be submitted with the EOI.

EOI must be delivered in a sealed envelope to the address mentioned below latest by 6th September, 2011, within 17:00 hours and be clearly marked “**Expression of Interest for empanelment of vendors for purchase of scrap materials at Bengaluru International Airport**”. BIAL shall not be responsible for the loss or non-receipt or delay in the receipt of any EOI application, sent by post or courier. The applicant shall submit 2 sets of the EOI documents in hard copy and/or in soft copy at the address mentioned below.
